Being Licenced as a Minister by the government requires that

Registration of minister/clergy is only to be made to meet the needs of the organization for marriage services in connection with a congregation, branch or local unit of the religious body. **Registered minister/clergy must solemnize marriages in accordance with the rites and usages of the religious organization they are registered with.** The government may, at any time, audit a religious organization or its minister/clergy to determine if they continue to meet the criteria under which they were registered, current policy and legislation. Please ensure that you relay this information to the minister/clergy you have registered. **As Governing Authority, it is your responsibility to ensure your Minister/Clergy are following the law and all applicable policies and procedures.**
